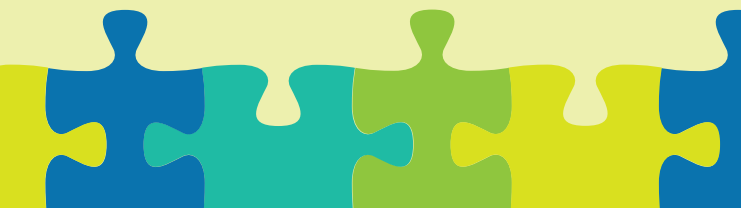

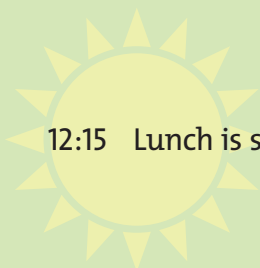

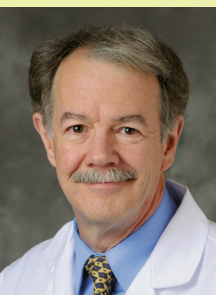

Peter A. LeWitt, MD, M.Med.SC

Dr. LeWitt directs the Henry Ford Parkinson's Disease and Movement Disorders Program. He also serves as professor of neurology at Wayne State University School of Medicine. His undergraduate, research and medical education is from Brown University, with additional postgraduate medical and research training at the University of Pennsylvania School of Medicine, Stanford University School of Medicine, and the National Institutes of Health. Since 1994, he has been listed in Best Doctors in America. He is the author of more than 300 publications on clinical and basic neuroscience and has served as an educator for the American Academy of Neurology, the movement disorder society, and numerous teaching programs in the U.S. and elsewhere. He currently serves as President of the Michigan Parkinson Foundation.


